Do You Know Your Cost of Doing Business?

An independent installer with one assistant must know the cost of installation BEFORE determining how much to charge for services! The hypothetical chart below is designed for an owner (lead installer) and one assistant. The figures include an office operated from the home - no warehouse space. It is to be used ONLY as a guide.

Costs vary from crew to crew, from city to city and according to the types of materials installed. Additional costs must be included. This includes a paycheck for the owner and assistant and a net minimum profit of 6% for the business to be profitable.

The chart is designed for a professionally operated business which includes paying all taxes and providing medical insurance for two families (retirement planning is not listed). Perhaps, you only need to earn \$50,000 this year or your goal is \$100,000 or more for a personal paycheck to support your family. Expenses vary according to company.

Determine where you are for the year. Deduct 10 days of earnings or a well-deserved two-week vacation, which means you must earn more daily. The 8-hour workday for this chart begins when you arrive at the dealers to pick up flooring. Not included is waiting time or driving across town to pickup merchandise, etc. There are many variables to consider daily. Costs are listed for 260 days per year. 52 weeks of (5) 8-hour days, next by the week, then by the month and by the year. After the costs are determined, the following chart displays the amount that must be earned for the same periods.
